Promoter:

Game Changer (London) Limited. Registered in England and Wales. Company number 12647063 Registered address 12E Manor Road, London, United Kingdom N16 5SA (Us) trading as **GAMECHANGER**

1. Standard Terms:

1.1. The Promoter operates skill-based Competitions resulting in the allocation of Prizes in accordance with these Terms and Conditions.

1.2. Competitions are open to UK residents over the age of 18. Employees of the promoter or any who are professionally connected with the Competition the Promoter, Competition administration and this extends to their immediate families or households of these persons may not enter a Competition.

2. Game Changer Membership:

2.1. You will need to open an account registering with Us online. You will be asked to provide your valid email address, age and a contact phone number or sign up via a social media account. You are required to keep this information and any other personal information provided complete and up to date. You may have only one account. On approval by Promotor, you will be granted Membership and be eligible subject to these Terms and Conditions to be an Entrant in Competitions run by Promotor. Promoter will not be liable for any inability to be able to contact you due to any errors or inaccuracy in the personal details provided. Members details will be held in our database for Competition entry and for promotion of future Competitions.

3. Competitions:

3.1. Competitions are run at the discretion of the Promotor on the website www.gamechanger.co.uk and will have a specific Prize.

3.2. Competitions will run for a specified period as stated on the website. Promoter reserves the right to cancel amend or suspend a Competition if it becomes necessary to do so.

3.3. By entering a Competition online or by post, you confirm you are eligible and eligible to claim any Prize you may win (Entrant). Proof of eligibility may be required by the Promoter. By entering a Competition Entrant is deemed to have read and accepted these Terms and Conditions and agreed to be bound by them. The Promoter will disqualify any entries that are completed by third parties, incomplete, joint submissions, or are computer generated. Promoter will disqualify any entry it has reasonable grounds for believing has contravened any of these Terms and Conditions or any entrant that has acted in a way that is reasonably considered by Promoter to be illegal or not in the spirit of the Competition.

3.4. On entering a Competition, you acknowledge that your payment is for a Ticket to enter and does not guarantee you will win a Prize. Only entries with successful payments and the correct answer to



the skill question will be entered into the Competition and eligible to win a Prize. Refunds shall only be made for entries submitted after the closing date or if Promoter cancels a Competition.

- 3.5. In the event Promoter cancels a Competition entry fees paid will be returned to Entrants. Where the entry fee is returned Promoter shall have no further liability to the Entrant or any other person.
- 3.6. Ticket price will be that advertised on the Competition page on the Promoters website. Promoter may at its discretion on occasion offer free to enter Competitions. Free entry Competitions are limited to one entry per Member per Competition. Your Member account number is your entry number to the Competition. To be eligible for entry you must comply with the entry requirements for that Competition as stipulated on Promoters web site. These Terms and Conditions apply equally to free entry Competitions
- 3.7. Postal entry to a Competition is allowed free of charge. You must be registered as a Member on our website prior to sending any postal entry. Postal entries received from non-Members will be rejected. Postal entries must be by **postcard** enclosed in a correctly stamped envelope addressed to the Promoter on the postcard you must state precisely which Competition you are taking part in, its closing date and the answer to the skill question. You must also include your name, address, date of birth, contact phone number and email address. Free entries are limited to one per Member per Competition. Correctly completed received postal entries will be allocated a random ticket number. Postal entries must be received before the closing date of the Competition. Postal entries will not be included if tickets have sold out prior to receipt by Promoter. These Terms and Conditions apply to postal entries.

4. Competition Entry:

- 4.1. There is a limit to the number of entries per Member per Competition. This number will be displayed in the Competition details. If you exceed this Promoter reserves the right to void all your entries for said Competition, and if you win a Prize to award that Prize to the next eligible participant where the Prize has been received, to demand the return of said Prize.
- 4.2. To the extent permitted by law all Entries become the property of the Promotor and will not be returned.
- 4.3. Promoter does not accept any responsibility for Entries they do not received due to any cause, that are lost, mislaid, damaged, or delayed regardless of the cause. Proof of postage or transmission is not proof of entry. For the avoidance of doubt only tickets recorded on Promoter systems will be entered into the Competition. Promotor will display accessible to a Member (password protected) purchased or allocated ticket number(s) prior to any Competition closing date. Entrants are advised to check their entry(s) on Promoters website for any Competition entered prior to the closing date.
- 4.4. Competition will close when the last ticket is taken. Entries after this point will not be accepted. Promoter may close the Competition if it does not sell all tickets by the draw date and the draw for the Prize will take place. The Promoter reserves the right to extend the closing date of a Competition up to a maximum of three times.
- 4.5. Should a Competition conclude without all tickets being sold an alternative Prize may be awarded equivalent to 80% of the entrance fees taken. The promoter is entitled to retain 20% of the entry fees to cover administration, overhead costs, and the like.



5. Prizes:

- 5.1. To be eligible to win the Prize your answer to the skill question must be correct, incorrect answer ticket(s) will not qualify for a Prize award.
- 5.2. Prizes will be subject to availability as specified in the Competition web page on Promoters web site. At the discretion of Promoter, the Prize specified may be substituted with similar or a cash amount. Any costs associated which may become payable on receipt of Prize by Winner including insurance, taxes, and the like are the responsibility of the Winner. Promoter accepts no responsibility for the Prize once delivered; no insurance comes with the Prize once handed over to the Winner. The Promoter does not guarantee the value of the Prize. Promoter is not responsible for any damage caused to Prize during delivery.
- 5.3. Promoter accepts no liability for errors or omissions contained within the Prize details on Promoter's website. It is the responsibility of each entrant to satisfy him or herself as to the accuracy of such details. Promoter offers no warranty as to the suitability of any Prize, value, or condition.
- 5.4. Entrant agrees that under the consumer protection (Distance Selling) Regulations 2000 goods and services ordered online to be supplied within 30 days will not apply to this Competition

6. Winner selection:

- 6.1. The winning ticket will be selected by the Google Random Number Generator or another device mechanical or electronic that outputs a random result, the draw will be streamed live on Facebook. There will be only one Prize Winner per Competition, a limited number of Consolation prizes may be additionally awarded at the discretion of the Promoter. Consolation prize Winner selection will, when applicable, be carried out in the same manner as main Prize Winner selection. This section 6 will equally apply to Consolation prize winners as it does to Prize Winner. If an Entrants is selected that has not answered the skills question correctly Entrant will be disqualified.
- 6.2. The Promoter will attempt to contact the Winner as soon as practical after the winning number has been drawn. If the Winner(s) cannot be contacted within a period of 14 days (which may be extended at the discretion of Promoter) or a Winner is disqualified as a result for breaching these terms, the Prize will be forfeit and the draw taken again. The original Winner will have no claim against the Promoter. Ownership of any Prize remains with the Promotor until taken up by the legitimate Winner.
- 6.3. Promoter shall use reasonable endeavours to award the Prize to the correct participant. If due to reason of computer or related failure or human error and the Prize is incorrectly awarded, Promoter reserves the right to reclaim a Prize and award it to the correct participant at its sole discretion without admission of liability.

7. Winners:

- 7.1. Winners will be required to provide photo ID to prove age and identity, proof will also be required to the validity of any payment method used to purchase a ticket. Should a participant not comply, Promoter reserves the right to disqualify the entry and to select an alternative Winner.
- 7.2. Promotor will make reasonable endeavour to deliver the Prize to Winner within 14 days of proof of identity and payment method. A Prize may not be claimed by a third party. Promoter accepts no responsibility if a Winner is not able to take up the Prize. Promoter makes no warranty or



representation as to the quality or suitability of any of the Prizes offered Delivery charges may apply outside of mainland UK.

- 7.3. Promoter will request all Winners pose for photographs and videos that may be used in future marketing identifying them as a Winner of a Competition. If you are a Winner, you agree Promoter may use your name and County of residence to announce you as a Winner of a Competition or for any other reasonable related promotional purpose.
- 7.4. Should a Winner be disqualified for any reason covered in these Terms & Conditions, the draw will be rerun and may or may not be streamed live on Facebook.
- 7.5. Promoters decision is final, no correspondence will be entered into about the result of a Competition following its determination.

8. General:

- 8.1. If there is reason to believe you have breached any of these Terms and Conditions, Promoter may at its sole discretion, reserve the right to exclude you from participating in a Competition or further Competitions.
- 8.2. These Terms and Conditions will not create or be constructed as creating any form of joint venture, agreement, or partnership between any Member and Promoter.
- 8.3. Except for liability for death or personal injury caused by the negligence of Promoter; Promoter shall not be liable for any loss suffered including but not limited to personal property, to consequential (including economic) loss by reason of any act or omission by Promoter or its servants or agents in connection with the arrangements for supply of any goods or services by any person to the Member or in connection with any of the Competitions promoted.
- 8.4. Promoter reserves the right to amend these Terms and Conditions at any time. Any changes will be published on the Promoters website.
- 8.5. These Terms & Conditions and Competitions are governed by English Law and any matters related will be resolved under English Law and the Courts of England & Wales shall have exclusive jurisdiction.
